#### **New Study Team Members Webpage**


The IRB Office has launched a new **Study Team Members** webpage to help research teams quickly determine whether a researcher is an **internal** or **external** study team member in eIRB+.

Effective research requires thoughtful recruitment and retention strategies that consider research participant safety, privacy, and confidentiality. Even well-designed research can fall short without comprehensive and engaging recruitment and retention approaches.

The NUCATS <u>Recruitment and Retention (R&R) Consultation Service</u> is here to help you optimize your R&R procedures to reach your recruitment goals throughout the research process (i.e., pre-award to participant retention). Co-led by Kathryn Macapagal, PhD, and Andrés Alvarado Avila, with support from consultants James Foran and Bryant Norton,

the NUCATS R&R Consultation Service helps study teams enhance their R&R strategies and maximize enrollment and retention, with unique expertise on non-traditional forms of R&R like social media advertisements, dating app outreach, and community-engaged methods.

The R&R team has combined decades of experience and brings extensive knowledge engaging many populations for studies with various health outcomes and offers practical, evidence-informed recommendations tailored to each project's needs. Free consultations are available to Northwestern University Feinberg School of Medicine faculty, as well as clinical affiliates (Lurie Children's Hospital, AbilityLab, and Northwestern Memorial Hospital).
