# New Illinois Law on Creating Generative Al Likenesses

In 2025, a new Illinois law went into effect, banning the creation or distribution of audio/visual digital replicas of persons without their permission. This law is mainly targeted at commercial enterprises, but researchers should be aware

of possible implications for future studies. The full text of the law can be found on the **Illinois General Assembly website**.
