

Anyone with a Northwestern NetID may access the two comprehensive courses in <u>MyHR Learn</u> by searching "Onboarding for Northwestern Research" or "Offboarding for Northwestern Research" and elect to take any combination of available modules, separated by Class ID codes. Find IRB Office modules under Class IDs "OR-ONBOARD-IRB" and "OR-OFFBOARD-IRB".

The IRB Office modules are also available for public access, without a Northwestern NetID, under the Education section of our website on our <u>new! IRB Courses webpage</u>. The public access courses may be particularly useful for incoming researchers who want a head start to onboarding but have yet to obtain a Northwestern NetID. New guidance on Diversity and Inclusion in Clinical Research

The IRB Office's Fostering Accessibility and Inclusion in Research (FAIR) Team is highlighting a guidance from the Multi-Regional Clinical Trials Center (MRCT) titled "Achieving Diversity, Inclusion, and Equity in Clinical Research" on the **FAIR Resources page**. This guidance



emphasizes the importance advancing goals for and offering practical and actionable strategies to enhance diverse participant representation in clinical research. The guidance identifies several barriers to the inclusion of diverse populations and addresses potential approaches and solutions to increase diversity. We encourage the Northwestern research community to engage with materials shared on our **FAIR resources page** as we work together to think critically about our research work through the lens of diversity, equity, inclusion, and justice.
